LABOR RATES FROM U.S. DEPARTMENT OF LABOR Highway Wage Decision No. ND 180002 is now superseded by ND 190001.

The U.S. Department of Labor published the statewide Davis-Bacon wage decision on Friday, January 4, 2019, with a new number and date. The ND Highway wage decision will now be ND1 (superseding ND2). The new wage decision has a new number and date, but no changes were made to the wages contained in the January 4, 2019 wage decision. This new wage decision will not be included in proposal let in the January 11, 2019 bid opening, but will be included in bid openings subsequent to that date.

This is a reminder that your 2018 annual bid bond, tax clearance statement, and subcontractor registrations will expire on December 31.

Prime contractors, you can find our annual bid bond form SFN 50231 on our website at <https://www.dot.nd.gov/forms/sfn50231.pdf> . Please notify your surety company to use the current form. The form can be completed online, but you'll have to print it and submit it on white paper with original signatures as you have done in the past. The single-project bid bond form SFN 14196 is also available on our website. Both forms can be found under the contractor category. The annual bid bond is preferred if you are submitting multiple bids throughout the year. It must be submitted to and approved by our office prior to any bid opening in which you intend to bid.

Prime contractors, if you bid on NDDOT projects and are awarded a contract in 2019, you'll have to submit a current tax clearance statement issued from the ND Tax Commissioner before the contract is signed by NDDOT. If you haven't already done so, you will also need to submit a tax clearance statement before we can make a final construction payment to your firm in 2019. It can be sent to me by mail, email, or fax.

Subcontractors, your 2018 Subcontractor Registration Request will expire on December 31. Subcontractor registrations need to be renewed annually if you intend to work on NDDOT projects as a **subcontractor only** in 2019 and beyond. If you are currently prequalified as a prime contractor with NDDOT, it is **not** necessary to submit a subcontractor registration request to do subcontractor work on our projects. If you are a current DBE subcontractor, certified with NDDOT, it is **not** necessary to submit this form. **You have two options in which you may submit your subcontractor registration. You can submit the form (SFN 52243) found on our website or you can register online at <https://dotnd.diversitycompliance.com/> . Only one option should be used.**

NDDOT Erosion & Sediment Control Certification Program

This four-year certification is **required** of all Prime Contractor Erosion Control Supervisors, Subcontractor Erosion Control Supervisors, NDDOT personnel and consultants working on NDDOT construction projects. Topics include: Regulations & Special Provisions, temporary and permanent erosion and sediment control measures, SWPPP, and project management. The cost for the class is \$300. **If your certification expires before the next construction season, you must attend one of the below courses to maintain your certification.** [Click Here](#) to verify your certification.
