### **101** SF 159 SE COLUMBUS SHLDR WID HSIP 421-1(13)5 CONTRACT NO. 04425

Reconstruction and roadway widening to address roadway departure crashes. Project is in Stillwater County on Secondary 421 from five to seven miles southeast of the junction with Highway 78. The reconstruction portion of the project begins at RP 4.8 and ends at RP 5.9. The rumble strip only portion of the project begins at RP 5.9 and ends at RP 6.9. There will be some guardrail work done to existing guardrail withing the rumble strip only portion of the project. The completed project will improve the horizontal and vertical alignments and improve sight distance throughout the length of the project.

### **102** N 7TH AVENUE - BOZEMAN NH 118-1(7)0

N 7TH AVE INT IMPROV - BOZEMAN CMDP 118-1(5)0 CONTRACT NO. 02525

N 7TH AVE INT IMPROV – BOZEMAN (CMDP 118-1(5)0) Signal upgrades, ADA sidewalk upgrades, intersection improvements, grading, gravel, plant mix surfacing, seal & cover, and pavement markings on the N 7th Ave Int Improv – Bozeman project located in Gallatin County. The project is located on N 7th Avenue in Bozeman and includes improvements at the following intersections: W Mendenhall St, Durston Rd/W Peach St, W Tamarack St, W Oak St. The project begins south of N 7th Ave/W Mendenhall St intersection near RP 0.0, extends north, and ends north of N 7th Ave/W Oak St intersection near RP 1.0.

N 7TH AVENUE – BOZEMAN (NH 118-1(7)0) Cold milling, overlay, crack seal, seal & cover, bituminous pavement removal & replacement, and pavement markings on the N 7th Avenue - Bozeman project located in Gallatin County. The project is located on N 7th Avenue in Bozeman and begins at W Main Street near RP 0.0, extends north, and ends at Nikles Drive/Wheat Drive near RP 1.4.

### **103** DENTON - E & W STPP 81-1(38)8 CONTRACT NO. 12R23

Scrub seal, 0.15' overlay followed by a seal and cover and new centerline rumble strips from the project beginning to the town of Denton, within Denton 0.15' mill/fill of the travel lanes followed by a full width seal and cover. New signing and pavement markings throughout the length of the project. The project is located on MT-81 (P-81) in Fergus County, beginning west of the town of Denton and terminating on the east side of the town of Denton. The route is classified as a rural minor arterial. The project was nominated to begin approximately 5 miles east of Denton at RP 8.00 and extend to the east for 5.8 miles where it ends at RP 13.8.

### **104** DENTON - E & W STPP 81-1(38)8 CONTRACT NO. 12R23

Scrub seal, 0.15' overlay followed by a seal and cover and new centerline rumble strips from the project beginning to the town of Denton, within Denton 0.15' mill/fill of the travel lanes followed by a full width seal and cover. New signing and pavement markings throughout the length of the project. The project is located on MT-81 (P-81) in Fergus County, beginning west of the town of Denton and terminating on the east side of the town of Denton. The route is classified as a rural minor arterial. The project was nominated to begin approximately 5 miles east of Denton at RP 8.00 and extend to the east for 5.8 miles where it ends at RP 13.8.

### **105** 14TH AVE - HAVRE UPP 5712(5) CONTRACT NO. 03525

This project proposes to 3/4" micro mill, crack seal, and seal & cover 14th Ave. in Havre, MT. The project begins at the intersection of 14th Ave. and 7th St. and extends north approximately 0.4 miles, terminating at the concrete/asphalt connection near the intersection of 14th Ave. and 2nd St.
