101 FLATHEAD RIVER-3M NW BIGFORK STPB-STPP-SSS 82-1(6)5 CONTRACT NO. 02625

Bridge replacement (Sportsman's Bridge) including grading, and plant mix bituminous surfacing on the Flathead River-3M NW Bigfork project. The project is located along Montana Highway 82 from RP 5.0 to RP 6.4 in Flathead County, approximately 3 miles northwest of Bigfork.

102 US 93 - N VICTOR & S RAVALLI NH-HSIP 7-1(180)60 CONTRACT NO. 03625

The US 93-N Victor & S Ravalli project will perform the following work in Lake County on US-93 (N-5), south of Ravalli, from reference post 20.1 to 26.7: • Crack seal full width of roadway. • Microsurfacing Rut fill of the 2 travel lanes. • Seal and cover and fog seal across the travel, median and turn lanes, and 3' into the shoulder. • Other work will include signing and delineation upgrades, pavement markings, and rumble strips. The South of Ravalli segment is entirely located within the Flathead Reservation. The US 93-N Victor & S Ravalli project will also perform the following work in Ravalli County on US-93 (N-7), north of Victor, from reference post 69.4 to 69.9: • Safety elements, consisting of a high friction surface treatment, asphalt mill/fill at the bridge ends of the wildlife underpass bridge at RP 69.7, curve signing, panel delineation, w-beam guardrail delineation, pavement markings, and rumble strips.

103 HOMESTAKE PASS PARKING AREA IM 90-5(96)233 CONTRACT NO. 04625

The project site is located at the Homestake Pass Truck Parking Area adjacent to Interstate 90 (I-90), approximately 9 miles east of Butte, MT, in Jefferson County. The project includes work includes upgrading the vaulted toilets, mitigating future stormwater inundation through site grading, and incorporating retention ponds. Anticipated project improvements include new lighting configurations around the new vaulted structures, new heated sidewalk areas, updated maintenance facilities and capabilities, new historical/cultural signage, and new site-related signing along I-90.

104 SF229 GUARDRAIL DIST. 2 AND 3 HSIP STWD(969) CONTRACT NO. 01625

The SF 229 GUARDRAIL DISTICT 2 & 3 project is a guardrail project with signing in Park, Gallatin, Jefferson, and Lewis & Clark Counties. Guardrail is to be installed or replaced at sites 1, 2, 3, 4, 5, 6, 7, and 8. Signing is to be updated at sites 3, 4, 6, 7, & 8. Pavement markings are to be updated at site 3

105 CLARK FORK - 1M NE BEARMOUITH STPB 9020(26) CONTRACT NO. 05625

Project Clark Fork – 1M NE Bearmouth is located in Granite County on Bear Gulch Road (off-system route C020009A) approximately 1 mile northeast of Bearmouth. The work for this project is to rehabilitate the existing bridge by repairing deteriorated concrete in the top portions of the prestress concrete T-Beams. New bridge end signing will be included.
